KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, a majority of whom are freeholders, citizens, and residents, of the State of Idaho have this day voluntarily associated ourselves together for the purpose of forming a Corporation under the laws of the State of Idaho.

AND WE HEREBY CERTIFY:

FIRST. That the name of the said Corporation shall be \_\_\_\_\_

Whitney Reservoir & Litch Company.

SECOND. That the purposes for which it is formed are to

have and to hold real and personal property; to own and conduct power lines for milling electricity and other purposes; to store water for irrigation and domestic purposes and for all other purposes necessary to the use and acquisition of water.

THIRD. That the place where the principal business of said Corporation is to be transacted is Whitney Idaho

FOURTH. That the term for which the said Corporation is to exist is fifty years, from and after the date of its incorporation,

FIFTH. That the number of Directors or Trustees of said corporation shall be five, and that the names and residences of the Directors or Trustees, who are appointed for the first year, a majority of the members being present and voting, and to serve until the election and qualification of such officers, are as follows to-wit;
