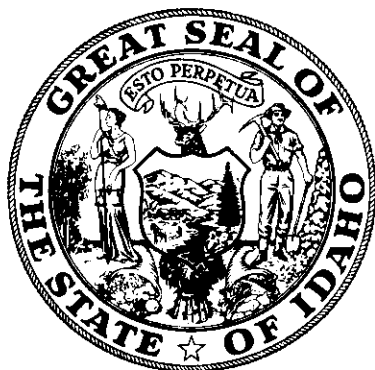

KNOW ALL PERSONS BY THESE PRESENTS: That the undersigned, acting as incorporator of a nonprofit corporation under the laws of the State of Idaho, Title 30, Chapter 3, Idaho Code, for the purposes hereinafter stated, adopts these Articles of Incorporation:

I

The name of this corporation shall be Terteling Family Memorial, Inc.

II

This corporation is a nonprofit corporation.

III

The term for which this corporation exists shall be perpetual.

IV

The location and street address of the registered office of this corporation shall be 600 First Security Bank Building, 9th & Idaho Streets, Boise, Idaho 83702, and the name of the registered agent at that address shall be N. L. Terteling.

V

The objects and purposes for which this corporation is formed are as follows:

1. To acquire burial lots within Morris Hill Cemetery, Boise, Idaho;
2. To provide a permanent burial and memorial area legally described after the names of the following immediate family members of Joseph August Terteling and Vady Jane Terteling together with the spouses named below (Terteling Family Memorial Participants):

- a) Joseph August Terteling
Vady Jane Terteling

Lots 3 and 4 of Block 242 in
Section Q of Morris Hill Cemetery
according to the official plat
thereof recorded in the Office of
the Recorder, Ada County, Idaho.

- b) Lloyd Peter Terteling

Section Q of Morris Hill Cemetery
according to the official plat
thereof recorded in the Office of
the Recorder, Ada County, Idaho.

- c) Joseph W. Terteling

The legal descriptions set forth in paragraphs 2(a)-(f) together with the area legally described as follows shall constitute the Terteling Family Memorial:

Lots 3 and 4 of Block 179, Lots 3 and 4 of Block 192, Lots 3 and 4 of Block 202, Lots 3 and 4 of Block 215, Lot 6 of Block 223, Lots 1 through 6 of Block 225, Lot 1 of Block 226, Lot 1, 2 and 3 of Block 234, Lots 1, 2, 5 and 6 of Block 235, Lots 4, 5 and 6 of Block 236, and Lots 1 through 6 of Blocks 241, 243, 247, Lots 3 and 4 of Block 248, Lots 1 through 6 of Blocks 249, 253, 254, 255, 256, 257, 258, all of which are in Section Q of Morris Hill Cemetery according to the official plat thereof recorded in the Office of the Recorder, Ada County, Idaho.

3. To provide a permanent burial area legally described after the names of the following descendants of Joseph August Terteling and Vady Jane Terteling together with Charlotte V. Terteling, who is a spouse of Joseph W. Terteling (Terteling Surrounding Area Participants):

Lots 5 and 6 of Block 179, Lot 1 of Block 180, Lots 5 and 6 of Block 192, Lot 1 of Block 191, Lots 5 and 6 of Block 202, Lot 1 of Block 203, Lots 5 and 6 of Block 215, Lot 1 of Block 214, all of which are in Section Q of Morris Hill Cemetery according to the official plat thereof recorded in the Office of the Recorder, Ada County, Idaho.

d) Joseph L. Terteling
Ann T. Sparks

Lots 2 through 6 of Blocks 180, 191, 203, 214, 226, and Lots 4, 5 and 6 of Block 234, all of which are in Section Q of Morris Hill Cemetery according to the official plat thereof recorded in the Office of the Recorder, Ada County, Idaho.

The aforementioned legal descriptions set forth in this paragraph 3 are collectively referred to as the Terteling Surrounding Area.

4. To provide for the perpetual care and upkeep of the Terteling Family Memorial and the Terteling Surrounding Area.

5. To enter into agreements with individuals named in Article V(2)(e) and (f) and Article V(3) of the Articles of Incorporation. To enter into agreements with the estates and/or heirs at law of the individuals named in Article V(2)(a)-(d). Said agreements shall include the following provisions and any additional provisions the Terteling Family Memorial, Inc. deems consistent with the purposes of this corporation as set forth in the Articles of Incorporation:

- a) No Terteling Family Memorial Participant shall ever be exhumed from the Terteling Family Memorial;
- b) The Terteling Surrounding Area Participants shall have the right to allow any spouse of Participant, any descending lineal descendant of Participant, and any spouse of any descending lineal descendant to be interred in the portion of the Terteling Surrounding Area legally described following their names in paragraph 3.

VI

The governing body of this corporation shall be managed and conducted by a Board of Directors of not less than three (3) persons, the exact number of persons to serve on such Board to be specified in the bylaws. The Board of Directors shall be elected by the Board of Directors of J. A. Terteling & Sons, Inc., an Idaho corporation with an office at 600 First Security Bank Building, 9th & Idaho Streets, Boise, Idaho 83702. The names and post office addresses of the initial members of the Board of Directors named by the incorporators to serve until the first election of directors are as follows:

The power to alter, amend or repeal the bylaws, or to adopt new bylaws, shall be vested in the Board of Directors.

This corporation shall have no members.
