ARTICLES OF INCORPORATION

OF

SECRETARY OF STATE

D & J ENTERPRISES, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is D & J ENTERPRISES, INC..

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is one hundred (100). They shall be without par value. Transfer of these shares shall be restricted for the purposes of maintaining the control relationship established by the director and shareholders and giving the existing shareholders the right to approve of a potential shareholder, all of which are necessary to the prudent conduct of the profit-making enterprises to be conducted.

FIFTH: Provisions for the regulation of the internal affairs of the corporation are set forth in the bylaws of the corporation to be adopted by the directors.

SIXTH: The address of the initial registered office of the corporation is 1805 Senator Street, Boise, Idaho 83709, and the name of its initial registered agent at such address is Joyce I. Harness..

SEVENTH: The number of directors constituting the initial board of directors of the corporation is two, and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
