ARTICLES OF INCORPORATION

FLYING SQUIRREL BAR AND RESTAURANT, INC.

The undersigned, acting as the incorporator under the provisions of the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

NAME

The name of the corporation is FLYING SQUIRREL BAR AND RESTAURANT, INC.

DURATION

The period of its duration shall be perpetual.

PURPOSES

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

STOCK

The corporation shall have the authority to issue Ten Thousand Shares (10,000) shares of capital stock, all of one (1) class, with each share having a par value of One and No/100 Dollars (\$1.00).
