The undersigned, acting as Incorporators of a Corporation under the Idaho Non-Profit Corporation Act, adopt the following Articles of Incorporation for such Corporation:

1. **NAME:** The name of the corporation is FIRST SECURITY GAMES, INC.

2. **DURATION:** The period of its duration is perpetual.

3. **NON-PROFIT:** This is a non-profit corporation.

4. **PURPOSES:** The purpose or purposes for which the Corporation is organized are to operate for the advancement of civic, educational and charitable purposes for the fostering, encouraging, or engaging in athletic exercise and to promote the physical and mental health of the citizens of the State of Idaho; further to encourage and to enhance the awareness of and participation in amateur sports, particularly, but not exclusively, those sports which are recognized in the Olympic Games, for health, education, and welfare of the citizens of the State of Idaho; to operate exclusively for such charitable and educational purposes as will qualify as an exempt organization under 501(c)(3) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent Federal Tax Laws, including making distributions to organizations which qualify as tax-exempt organizations under that Code.

5. **MEMBERSHIP:** This Corporation shall have no members. It shall be governed by the Board of Directors and officers.
