



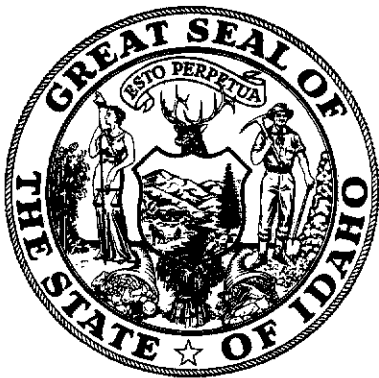

## ARTICLES OF INCORPORATION

In order to organize a corporation for profit under the Idaho Business Corporation Act, the undersigned, who is a natural person of adult age and a citizen of the United States of America, hereby adopts the following ARTICLES OF INCORPORATION:

1. The name of the corporation is BCL ELECTRIC, INC.
2. The period of its duration is perpetual.
3. The purpose of the corporation is to engage in any activities not prohibited by law, including the sale and installation of electrical wiring and equipment.
4. The corporation is authorized to issue up to Twenty Thousand (20,000) shares of capital stock, all of one class, of par value Ten Dollars (\$10.00).
5. The internal affairs of the corporation shall be governed by Bylaws adopted by majority vote of the Board of Directors.
6. Transfer of shares shall be restricted by a requirement that before any shares can be transferred they must first be offered for sale to the corporation and other shareholders, as more fully set forth in the Bylaws.
7. The address of the initial registered office of the corporation is P.O. Box 9221, 206 West Morton Street, Moscow, Idaho 83843. The name of its initial registered agent at that address is Brent A. Loney.
8. The one (1) person whose name and address is set forth

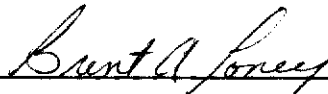

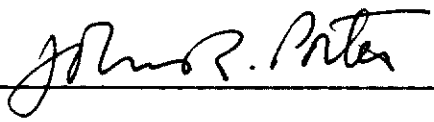
