## ARTICLES OF INCORPORATION

OF

The undersigned incorporator, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopts the following articles of incorporation:

ARTICLE ONE: <u>Name</u>. The name of the corporation is HANSEN FAMILY ENTERPRISES, INC.

ARTICLE TWO: <u>Duration Period</u>. The period of duration of the corporation is perpetual.
