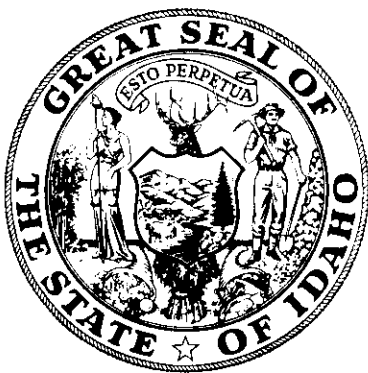

ARTICLES OF INCORPORATION
OF
ORCHARD GRAVITY FLOW SYSTEM, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Nonprofit Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is ORCHARD GRAVITY FLOW SYSTEM, INC.

SECOND: This corporation shall be a nonprofit corporation under the Idaho Nonprofit Corporation Act pursuant to Title 30, Chapter 3, Idaho Code.

THIRD: The period of the duration of this corporation shall be perpetual.

FOURTH: The purpose or purposes for which the corporation is organized are:

- (a) The transaction of any or all lawful business for which a nonprofit corporation may be incorporated under the Idaho Nonprofit Corporation Act, and in addition thereto, to operate and maintain a water distribution system for irrigating water to lands owned by the members of the corporation.

FIFTH: The corporation shall have memberships issued to the landowners under which the water distribution system of the corporation shall serve.

SIXTH: The regulation of the internal affairs of the corporation, shall be provided for by its Bylaws.

SEVENTH: The initial registered office shall be at the home of John A. Bear, Star Route, Council, Idaho 83612, and the name of the initial registered agent shall be John A. Bear whose address is Star Route, Council, Idaho 83612.




