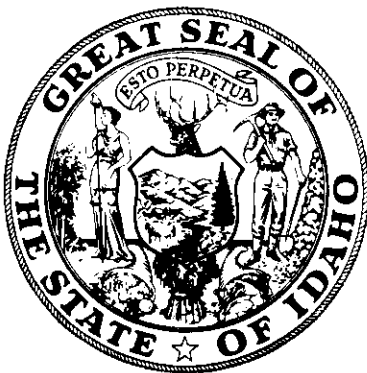

ARTICLES OF INCORPORATION  
OF

ERICKSON-FORD COMPANY, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

Article I

NAME. The name of the corporation is ERICKSON-FORD COMPANY, INC.

Article II

DURATION. The period of its duration is perpetual.

Article III

PURPOSE. The purpose for which the corporation is organized is:

Any lawful business purpose, and without limitation of the foregoing, to provide contract drilling services to geotechnical engineering firms, mineral exploration services, hazardous waste drilling services and any other form or type of drilling services.

Article IV

STOCK. There shall be one class of stock, to be designated the common stock of the corporation, and the total number of shares authorized is 200,000 shares, each having a par value of \$10.00.

Article V

REGISTERED OFFICE AND REGISTERED AGENT. The address of the initial registered office of the corporation is 7450 Lemhi Street, Boise, Idaho 83709, and the name of its initial registered agent at such address is Ronnie Lee Ford.

Article VI

DIRECTORS. The number of directors constituting the initial board of directors of the corporation is three (3), and the

names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:

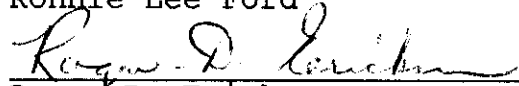

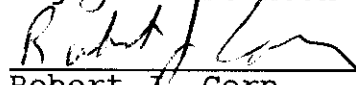
