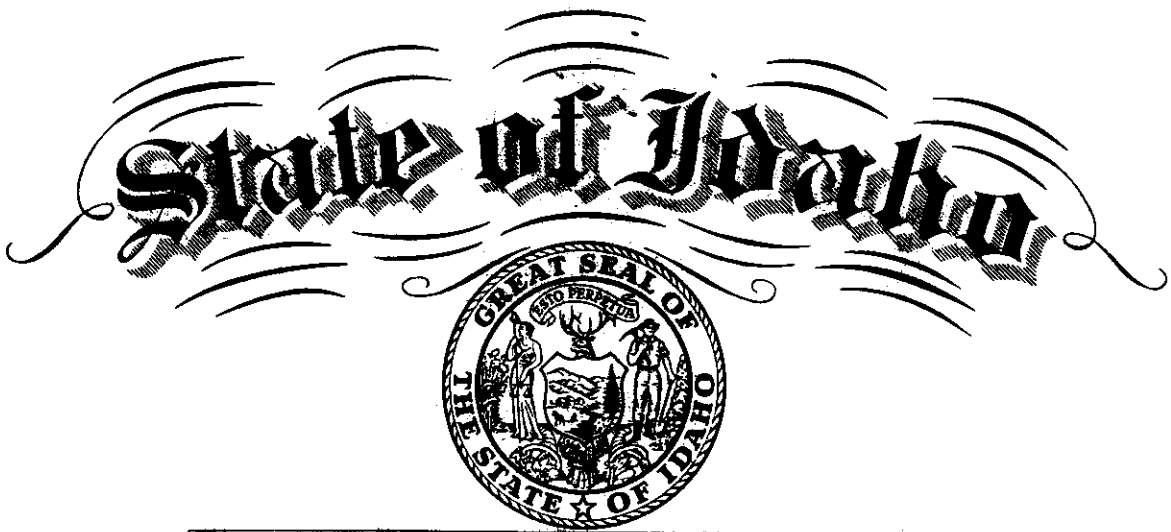

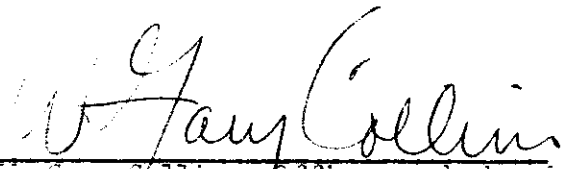

The name of this Corporation shall be PACIFIC WESTERN CORPORATION,

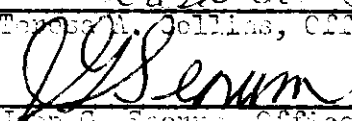
And, FURTHER, the undersigned certify they have complied in all respects with Section 30-216(5), Idaho Code.

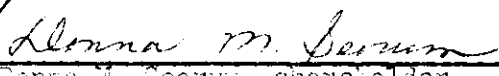
WHEREFORE, they pray that the Articles of Incorporation of said Corporation be so amended and a certificate of amendment be issued.
