**ARTICLES OF INCORPORATION OF
IDAHO ARTISTRY IN WOOD ASSOCIATION, INC.**

The undersigned, who are citizens of the United States and the State of Idaho, desiring to form a Non-Profit Corporation pursuant to Idaho Code § 30-3-27 and Internal Revenue Code Section 501 (c) (7) do hereby certify:

ARTICLE I: Name

The name of the Corporation shall be IDAHO ARTISTRY IN WOOD ASSOCIATION, INC.

ARTICLE II: Purpose

The purpose of the organization/social club shall be to foster and encourage enthusiasm for all types of wood working and the exhibition and judging of such artistic productions during the annual Idaho Artistry in Wood Show. The organization will encourage local and regional wood working clubs to participate in the activities of this corporation, in particular its annual show. Such groups will include but not be limited to the Idaho Woodcarvers Guild, the Treasure Valley Scrollers, the Southwest Idaho Wood Turners Association, the Idaho Gourd Society, the Ada County Woodworkers Association, and citizens at large with interests in wood artistry. The associated clubs do not discriminate on any basis: gender, race, color, creed, or orientation.

ARTICLE III: Registered Agent & Physical Address

ARTICLE VII: Voting Status


Voting will be limited to members of the Board and to ad hoc committees appointed by the Board to serve in special capacities for the corporation.
