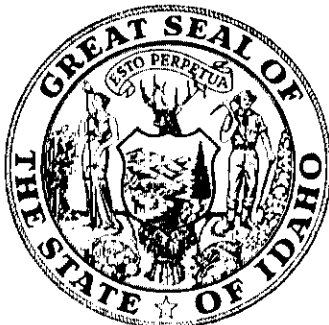
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

OF

CAT'S EYE, INC.

THE UNDERSIGNED, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Cat's Eye, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which this corporation is formed shall be the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 500 shares of common stock without par value.

FIFTH: Provisions denying preemptive rights are: None.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are such as may be provided by the By-Laws of the corporation, including provision for restriction on transfer of shares, as provided in the Idaho Business Corporation Act, Section 30-1-23A.

SEVENTH: The address of the initial registered office of the corporation is P. O. Box 535, ^{130 N MAIN ST} Mountain Home, Idaho, and the name of its initial registered agent at such address is Carl L. Holmes.

EIGHTH: The number of directors constituting the initial board
