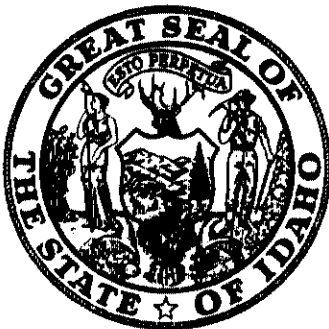
CERTIFICATE OF INCORPORATION OF

ARTICLE I.

Name

The name of the corporation is JAIL HOUSE PIZZA INCORPORATED

ARTICLE II.

Duration

The duration of the corporation is perpetual.

ARTICLE III

Purpose

The purpose of the corporation is to provide take out pizza & deli sandwiches to the public, to encourage profitable business and commercial activity, and to transact any or all lawful business for which corporations may be incorporated under the laws of the State of Idaho.

ARTICLE IV.

AUTHORIZED SHARES

The total authorized numbers of par value share is 100 with no par value. All shares will be of one (1) class only.

ARTICLE V.
