PLAN AND AGREEMENT OF MERGER OF BOB RICE LEASING COMPANY INTO BOB RICE FORD, INC.

- 1. The names of the constituent corporations are Bob Rice Ford, Inc., (Bob Rice Ford), an Idaho corporation, and Bob Rice Ford Leasing Company (Bob Rice Ford Leasing), an Idaho corporation.
- 2. The name of the surviving corporation is Bob Rice Ford, Inc. (Bob Rice Ford), an Idaho corporation.
- 3. Bob Rice Ford Leasing shall be merged into Bob Rice Ford, which shall be the surviving corporation, such merger to be effective at 12:01 a.m., April 1, 1984, which is a date not more than thirty days subsequent to the filing of Articles of Merger with the Office of the Secretary of State of Idaho.

Upon the effectiveness of the merger:

- (a) The outstanding common shares of Bob Rice Ford, \$100.00 par value, shall not be changed;
- (b) Each issued and outstanding common share of Bob Rice Ford Leasing, \$1.00 par value, shall forthwith be converted into .9065164 share of Bob Rice Ford, \$100.00 par value, which shall thereupon be issued and outstanding and any fractional shares shall be paid for in cash:

- (c) All common shares of Bob Rice Ford Leasing held in its treasury, if any, shall be cancelled and no shares issued in lieu thereof.
- 4. Anything herein to the contrary notwithstanding this Plan of Merger may be terminated and abandoned at any time prior to the filing of the Articles of Merger with the Office of the Secretary of State of Idaho.
