ARTICLES OF INCORPORATION OF HAYDEN LAKE VOLUNTEER FIRE DEPARTMENT, INC.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned all of whom are of legal age and citizens of the United States, have this day voluntarily associated ourselves and do hereby, and by these Articles of Incorporation, unite and associate ourselves for the purpose of forming a nonprofit Corporation under and pursuant to the provisions of Chapter 11, Title 30, of the Idaho Code, and we hereby acknowledge, enter into, and adopt the following Articles of Incorporation:

I.

The name of this Corporation shall be HAYDEN LAKE VOLUNTEER FIRE DEPARTMENT, INC.

II.

The period of the duration of this Corporation shall be perpetual.

III.

The principal office in the State of Idaho of this Corporation is at the Village of Hayden, County of Kootenai, Hayden Lake, Idaho.

IV.

In furtherance, and not in limitation of the general powers conferred by the laws of the State of Idaho, this Corporation shall have the following objects, purposes and powers:

 To fight fires; to provide first aid and ambulance services for the sick and injured; to provide instruction in first aid and water safety; to participate in State and National civil defense work; to render assistance in any local, County, State or national emergencies and render such other emergency aid as may be practicable; to acquire and own fire apparatus for use by the Corporation in the protection of persons and property from injury, loss, damage or destruction by fire and fraud; to own and acquire land and to construct and erect buildings for corporate purposes, for the use of the members of the Corporation in connection with the housing of fire apparatus and for the providing of a place of meeting and general recreational and other facilities for the members of the Corporation.

2. To advance the services of the Corporation primarily in the general Hayden Lake area.

#### ARTICLE V.

This Corporation is not organized for profit and it shall have no capital stock.

### ARTICLE VI.

The conditions and regulations of membership and the rights or other privileges of the classes of members shall be determined and fixed by the By-Laws.

### ARTICLE VII.

The private property of the members shall not be subject to the payment of corporate debts, liabilities or obligations to any extent whatever.

## ARTICLE VIII.

The Board of Directors of this Corporation shall be not less than three (3) nor more than seven (7) who shall be elected by a majority vote of all members in good standing of said Corporation, and they shall be elected annually and shall consist of such officers as shall be designated as may be provided in the By-Laws of the Corporation.

#### ARTICLE IX.

These Articles may be altered and amended at a regular meeting of the organization at which a quorum is present, by

a vote of two-thirds (2/3) of the members present at such meeting, provided that written notice to that effect shall have been sent to the membership at least five (5) days prior to the date of such meeting and provided further that any proposed alterations or amendments must have been brought' before the membership at least thirty (30) days prior to the meeting at which said proposed changes and amendments are to be voted upon.
