ARTICLES OF INCORPORATION

OF

TO' AUTO REPAIR, INC.

WE, THE UNDERSIGNED CITIZENS OF THE STATE OF IDAHO, HEREBY DO ASSOCIATE OURSELVES FOR THE PURPOSE OF FORMING A CORPORATION UNDER THE LAWS OF THE STATE OF IDAHO, AND THUS HEREBY CERTIFY AS FOLLOWS:

- 1) THE NAME OF THIS CORPORATION SHALL BE Russ' Auto Repair, Inc.
- 2) THE GENERAL NATURE OF THE BUSINESS CONDUCTED BY THIS CORPORATION SHALL BE

 GENERAL REPAIR OF CAR ENGINES AND SMALL GASOLINE ENGINES USED IN OTHER APPLICATIONS.
- 3) IN FURTHERANCE OF THE GENERAL POWERS OF THIS CORPORATION, IT SHALL HAVE THE FOLLOWING POWERS IN THE CONDUCT OF ITS BUSINESS:
 - A) TO PURCHASE, LEASE, OR DEAL IN REAL PROPERTIES OF ALL KINDS AND DESCRIPTIONS,
 - B) TO PURCHASE, LEASE, OR DEAL IN PERSONAL PROPERTY AND EQUIPMENT OF ALL KINDS.
 - C) TO ENTER INTO AND PERFORM CONTRACTS OF ALL KINDS, TO BECOME A PARTNER IN ANY LAWFUL BUSINESS VENTURE, AND TO ACQUIRE AND DEAL IN ITS OWN STOCK OR SECURITIES, SHOULD THE NEED ARISE,
 - D) TO ESTABLISH PENSION AND PROFIT SHARING PLANS,
 - E) TO ACQUIRE OTHER BUSINESSES, EITHER THROUGH OUTRIGHT PURCHASE, OR THROUGH THE EXCHANGE OF ASSETS, GOODWILL, SECURITIES, OR OTHER CONSIDERATION,
 - F) TO APPLY FOR AND PURCHASE OR REGISTER PATENTS, TRADEMARKS, TRADEMARKS, OR ANY OTHER INTANGIBLE OBJECTS WHICH MAY BE NECESSARY OR INCIDENTAL TO THE CONDUCT OF ANY OF THE OBJECTS HEREIN ENUMERATED.
