

ARTICLES OF INCORPORATION

NAME.

The name of this Corporation shall be the Liberty Park Irrigation Company.

PURPOSE OF ORGANIZATION.

The purpose for which this Corporation is formed, is to own, and control and operate a canal, and the necessary lateral ditches, from Snake River, through a certain slough known as "Bannock Jim Slough", for the purpose of irrigation and domestic use.

PLACE OF BUSINESS.

Its office and principal place of business shall be at Liberty Park, Independence Post Office, Bingham County, Idaho.

TERM OF EXISTENCE.

The term for which this Corporation is organized and is to exist is fifty years from the date of its certificate of incorporation being issued.
