FIRST:

The name of the corporation is: LET'S SAVE AMERICA, INC.

The period of its duration is perpetual.

THIRD:

The purpose or purposes for which the corporation is organized

are: The transaction of a business and any or all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

authority to issue is 100,000. 50,000 shares shall be designated "Class A Shares" and 50,000 shares shall be designated "Class B Shares". Both classes shall have no par value. The preference, limitations and relative rights of the Class A Shares and the Class B Shares shall be identical in all respects, share for share, except that the voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the Class A Shares, and the holders of the Class B Shares shall not have any voting power except in instances as required by Idaho statute.
