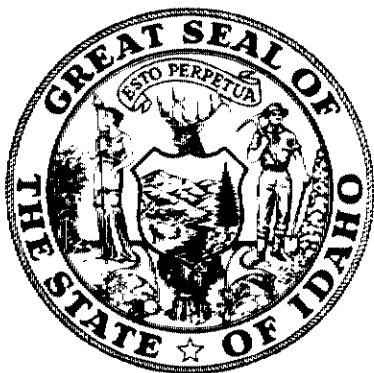

THOMAS THIBAULT and EVELYN THIBAULT, as President and Secretary, respectively, of Du-Rite Nursery, Incorporated, a corporation organized and existing under the laws of the State of Idaho, hereby certify that at a special meeting of the stockholders of said corporation, called for that expressly stated purpose, held at the office of the corporation in Meridian, Idaho, on March 26, 1985, at which meeting all of the stockholders of the corporation were represented and voted, the following resolution was, by unanimous vote of all of the stockholders and shares of stock of said corporation, adopted:

RESOLVED, that the Articles of Incorporation of this corporation be and the same are hereby amended so as to increase the number of authorized shares which the corporation is authorized to issue from 50,000 shares at \$1.00 par value to 250,00 shares at \$1.00 par value, and Article V of the said Articles of Incorporation is hereby amended to substitute 250,000 shares at \$1.00 par value in place of 50,000 shares at \$1.00 par value.
