



PLAN OF MERGER

Pursuant to Idaho Code Section 30-18-202, the following constitutes the Plan of Merger for the purpose of merging Ponderosa Development Corporation, Inc., into Albright & Thurston, Inc.

FIRST: The Surviving Entity is Albright & Thurston, Inc., a corporation formed under the laws of Idaho, currently in good standing, whose Articles of Incorporation were filed with the Idaho Secretary of State on March 25, 1991.

SECOND: The Disappearing Entity is Ponderosa Development Corporation, Inc., a corporation formed under the laws of Idaho, currently in good standing, whose Articles of Incorporation were filed with the Idaho Secretary of State on June 21, 1993.

THIRD: The effective date of this merger is July 1, 2011.

FOURTH: There are 1,000 shares of stock authorized to be issued by the Surviving Entity, all one class, of which 100 shares are presently issued, outstanding and held by its current shareholders. Of the remaining 900 authorized but currently unissued shares, 100 shares shall be issued to the shareholders of the Disappearing Entity (Ponderosa Development Corporation, Inc.), pro rata, in exchange for all of the outstanding shares of stock in the Disappearing Entity, whereupon Ponderosa Development Corporation, Inc. shall cease to exist, all of its property shall become the property of the Surviving Entity.


Thurston, Inc. and all liabilities of Ponderosa Development Corporation, Inc. shall become liabilities of Albright & Thurston, Inc.


FIFTH: This merger does not require an amendment to the Articles of Incorporation or any other public organic document of the Surviving Entity.


