ARTICLES OF INCORPORATION

OROFINO PHYSICAL THERAPY AND WELLNESS, INC.

I, the undersigned, being an adult citizen of the United States of America, for the purpose of forming a corporation pursuant to Chapter 1 of Title 30, Idaho Code, do hereby adopt and certify the following Articles of Incorporation, to-wit:

ARTICLE I

The name of the corporation shall be "Orofino Physical Therapy and Wellness, Inc."

ARTICLE II

The term of existence of this corporation shall be perpetual.

ARTICLE III

The purposes for which this corporation is organized are the transactions of any and all lawful businesses for which corporations may be incorporated under Chapter 1 of Title 30, Idaho Code.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is Five Thousand (5,000); the shares shall consist of one (1) class only; the par value of each share shall be the sum of Ten Dollars (\$10.00); the total authorized capital

1 stock of the corporation is the sum of Fifty Thousand Dollars (\$50,000.00). The stock
2 of this corporation shall be nonassessible.

4 **ARTICLE V**

5 The address of the initial registered office of the corporation is 1005 Michigan
6 Avenue, Orofino, Idaho, 83544. The name of the initial registered agent of the
7 corporation at the initial registered office of the corporation is John M. Garrison.

9 **ARTICLE VI**

10 The corporation shall have three (3) directors except in the event that all of the
11 shares of the corporation are owned beneficially and of record by fewer than three (3)
12 shareholders in which event the number of directors may be fewer than three (3) but not
13 fewer than the number of shareholders.

15 The initial Board of Directors shall consist of one (1) director. The name and
16 address of the person who is to serve as director until the first annual meeting of the
17 shareholders and until his successor is elected and qualified is:



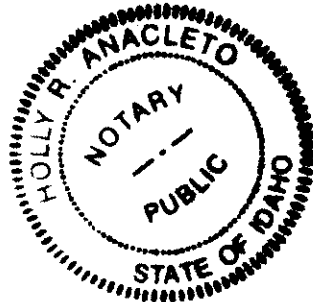


