ARTICLES OF INCORPORATION

O F

GERALD E. WEITZ, P. A.

The undersigned, who is duly licensed to practice the profession of dentistry in the State of Idaho, desires to form a
professional corporation pursuant to Idaho Law for the purpose of
rendering dental services, and adopts the following articles of
incorporation for such corporation:

ARTICLE ONE

Name

The name of the corporation shall be GERALD E. WEITZ, P.A.

ARTICLE TWO

Purpose and Powers

The purpose for which the corporation is formed is to engage in the general practice of dentistry.

In connection with the above-mentioned purpose, the corporation shall have the power to invest its funds in real property and securities, to acquire, own, and dispose of real and personal property, and to do all other acts to the extent permitted under Idaho Code 30-1307.

ARTICLE THREE

Principal Office

ARTICLE FIVE

Directors
