

ARTICLES OF INCORPORATION

OF

"SNAPS" Mfg., Inc.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is: "SNAPS" Mfg., Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are for the transaction of a business and any or all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of common shares, which the corporation shall have authority to issue is 100,000, of which 2,000 shall have voting rights and 98,000 shall not have voting rights. The shares shall have no par value.

FIFTH: The address of the initial registered office of the corporation is 4914-A Industrial Avenue East, Coeur d'Alene, Idaho 83815, and the name of its initial registered agent is Lawrence H. Ewert, Sr. The mailing address of the corporation shall be: 4914-A Industrial Avenue East, Coeur d'Alene, Idaho 83815.

SIXTH: The number of Directors shall be set by the Bylaws but the initial Board of Directors of the corporation shall be two (2), and the names and addresses of


