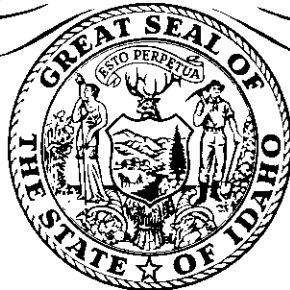

ARTICLES OF INCORPORATION
OF
AUTO-BALANCE AMUSEMENT COMPANY INCORPORATED

WE THE UNDERSIGNED, have this date voluntarily associated ourselves for the purpose of forming a corporation for profit under the laws of the State of Idaho and to that end do hereby adopt Articles of Incorporation as follows:

I.

The name of the proposed corporation is "Auto-Balance Amusement Company Incorporated".

II.

The purposes for which the corporation is forming are:

(1) To build, erect, construct, and manufacture automobile balancing devices for lease, sell, enter into contracts for sale and agreements for the operation and purchase of automobile balancing amusement devices.

(2) To operate automobile balancing amusement devices for the use of the public and to charge for the use thereof.

(3) To operate, lease, manage and to enter into agreements for the operation and management of concessions for the sale of confectionaries, food and beverages, souvenirs and other goods, wares and merchandise, incidental to the operation of an automobile balancing amusement device.

(4) To operate, manage, own, purchase, lease, sell, or contract for the sale of filling stations for the sale of gasoline, oil, lubricants, automotive supplies and accessories.

(5) To make and enter into all types of contracts, agreements, and obligations by or with any person or persons,

corporation or corporations for the purpose of carrying on such business.

(6) To draw, accept, endorse , acquire and sell negotiable or transferable instruments.

(7) To exercise full power to perform any and all acts connected with or arising from or incidental to, and all acts proper and necessary for the carrying on of such business.

III.

The duration of this corporation is perpetual.

IV.

The location and Post Office address of its registered office of the corporation in the State of Idaho, is Box 91 Route 2, Hayden Lake, Idaho.

V.

The total authorized number of shares of capital stock of the corporation is \$100,000.00 which has a par value of \$1.00 and which shall be divided into 100,000 shares.

VI.

The shares of stock are not to be classified and all shares shall be of equal voting power. Said shares of stock are transferable only upon the books of the corporation under the conditions and in the manner and subject to the restrictions set out in these Articles Of Incorporation and such other restriction as may be provided from time to time by the By-Laws of this corporation.

VII.
