

Being persons legally competent to enter into contract, for the purpose of forming a non-profit corporation under the laws of the State of Idaho we do hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of this corporation is the Idaho Academy of Physician's Assistants, Inc.

ARTICLE TWO

The address of its registered office in the State of Idaho at P.O. Box P in the City of Pocatello County of Bannock and the name of its registered agent at such address is Ronald D. Berge .

ARTICLE THREE

The duration of the corporation is 50 years.

ARTICLE FOUR

The purpose or purposes for which the corporation is formed are:

- (1) to develop a plan of assistance in the areas of education, patient care by trained professional personnel rendering skilled medical services and research; to encourage its members to render honest, loyal and more efficient service to the medical profession and to the public which they serve; to render educational service for the self-improvement of its members; to encourage and assist others engaged in the field of physician's assistants; to associate in various organizations in order to provide the highest quality of service to the medical profession and the public;

(2) to perform all acts deemed necessary or expediant to facilitate and implement the organization and self-improvement of its members, to include the acquisition of property both real and personnel by purchase or lease, the employment of personnel, contracting for courses of instruction, the incurring of liability, the establishment of centers for continuing education, negotiations with agencies of the County, State and Federal Government and generally, to perform all acts incidental to the successful operation of this organization.

ARTICLE FIVE

This corporation does not afford pecuniary gain, incidentally or otherwise to its members.

ARTICLE SIX

The member of the directors constituting the first board of directors shall be four (4) and the names, addresses and tenure in office of the persons who are to serve as directors (until the first meeting of the corporation or until their successors are elected and qualified) are:






