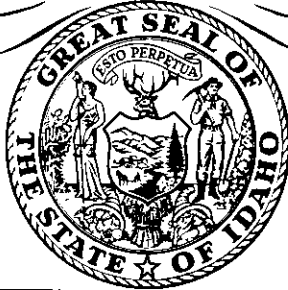

### CERTIFICATE OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho do hereby certify that the original of the articles of incorporation of

One Thousand Nine Hundred **Sixty-three** and duly recorded on Film No. **123** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103, Idaho Code.

ARTICLES OF INCORPORATION  
OF  
CAPITOL LEASE, INC.

We, the undersigned natural persons all over the age of twenty-one years and citizens of the United States acting as incorporators under the Idaho Corporation Laws, adopt the following Articles of Incorporation:

ARTICLE I.

The name of this corporation is Capitol Lease, Inc. its duration shall be perpetual.

ARTICLE II.

This corporation may engage in any commercial, industrial financial and agricultural enterprise calculated or designed to be profitable to this corporation and in conformity with the laws of the State of Idaho; further, in pursuance of such corporation purpose, this corporation may manufacture, purchase, or otherwise acquire, own, mortgage, pledge, sell, lease, assign, and transfer or otherwise dispose of, invest, trade, transport and deal with, goods, wares, services, and merchandise and real and personal property of every class and description.

In general and in connective with the foregoing, said corporation shall have and exercise all of the powers conferred under the laws of the State of Idaho, upon business corporations, and each and everything necessary, suitable or advisable for the accomplishment of the foregoing objects, or which at any time appear to be conducive to or expedient for the benefit of said corporation in connection therewith.

ARTICLE III.

The location and post office address of the registered office of this corporation in the State of Idaho is 1017 Jefferson Street, Boise, Idaho.

ARTICLE IV.

The total authorized number of shares which the corporation

shall have authority to issue is Two hundred (200) shares consisting of common voting stock only and the par value of each share shall be One Hundred Dollars (\$100.00), **making an aggregate of \$20,000.00.**

ARTICLE V.






ARTICLE VI.


