The undersigned, acting as the incorporator of a nonprofit corporation ("Corporation") organized under and pursuant to the Idaho Nonprofit Corporation Act, Chapter 3, Title 30, Idaho Code ("Act"), adopts the following Articles of Incorporation ("Articles").

**ARTICLE 1  
NAME**

The name of the Corporation is Bella Commons Phase 2 Homeowners Association, Inc.

**ARTICLE 2  
NONPROFIT STATUS**

The Corporation is a nonprofit membership corporation.

**ARTICLE 3  
PERIOD OF DURATION**

The period of duration of the Corporation is perpetual.

**ARTICLE 4  
REGISTERED OFFICE AND AGENT**

The location of the Corporation is in the City of Nampa, County of Canyon, and in the State of Idaho. The initial registered agent is Michael Christian. The address of the initial registered office is 101 S. Capitol Blvd. Ste. 930, Boise, Idaho 83702.

**ARTICLE 5  
PURPOSES**

The purposes for which the Corporation is organized and will be operated are as follows:

A. The exercise of all the powers and privileges and the performance of all the duties and obligations of the Corporation as set forth in the Declaration of Covenants, Conditions and Restrictions for Bella Commons Phase 2, recorded on the 29th day of April, 2019, in the official records of Canyon County, Idaho as Instrument No. 2019-015823 (the "Declaration"), as amended from time to time.

B. The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Nonprofit Corporation Act, subject only to limitations in the Bylaws and the Declaration and the amendments and supplements thereto.

C. To exercise all powers granted by law necessary and proper to carry out the foregoing purposes, including, but not limited to, the power to accept donations of money, property, whether real or personal, or any other things of value. Nothing herein contained shall be deemed to authorize or permit the Corporation to carry on any business for profit, to exercise any power, or to do any act that a corporation formed under the Act, or any amendment thereto or substitute therefor, may not at that time lawfully carry on or do.

**ARTICLE 6  
LIMITATIONS**

No part of the net earnings or the assets of the Corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article V hereof. No substantial part of the activities of the Corporation shall be for the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 528 of the Internal Revenue Code of 1986, as amended from time to time.

**ARTICLE 7  
MEMBERS**

Each person or entity holding fee simple interest of record to a Building Lot (as defined in the Declaration) which is a part of the Bella Commons, and sellers under executory contracts of sale, but excluding those having such interest merely as security for the performance of an obligation, shall be a Member of the Corporation. Membership shall be appurtenant to and may not be separated from ownership of any Building Lot located in the Bella Commons. Except for the Class B Member, there shall be one (1) membership in the Corporation for each Building Lot located in the Bella Commons. Members of the Corporation must be owners of Building Lots within the Bella Commons.

**ARTICLE 8  
VOTING RIGHTS**

The Corporation shall have two (2) classes of voting membership:

A. **Class A Members.** The Class A Members shall be owners of Building Lots within the Bella Commons, except for Grantor (as defined in the Declaration). The Class A Members shall be entitled to one (1) vote for each Building Lot owned by such Class A Members on the day of the vote.

B. **Class B Member.** Envision Idaho, LLC, an Idaho limited liability company, (“Grantor”) shall be the Class B Member, and shall be entitled to six (6) votes for each Building Lot owned by Grantor within the Bella Commons. The Class B Member shall cease to be a voting Member in the Corporation when the total cumulative votes of the Class A Members equal or exceed the total votes of the Class B Member, provided that the Class B membership shall not cease before the expiration of ten (10) years from the date on which the first Building Lot is sold to an owner.

**ARTICLE 9  
BOARD OF DIRECTORS**

The affairs of the Corporation shall be managed by its Board of Directors. The number of Directors serving on the Board of Directors shall be fixed in accordance with the Corporation’s Bylaws. Other than the Directors constituting the initial Board of Directors, who are designated in these Articles, the Directors shall be elected in the manner and for the term provided in the Bylaws of the Corporation.

**ARTICLE 10  
ASSESSMENTS**

Each Member shall be liable for the payment of Assessments provided for in the Declaration and as otherwise set forth in the Bylaws of the Corporation.

**ARTICLE 11  
DISTRIBUTION ON DISSOLUTION**

Upon dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the Corporation, distribute all the assets of the Corporation consistent with the purposes of the Corporation to such organization or organizations as shall at that time qualify as exempt organizations under Section 501(c)(12) of the Internal Revenue Code of 1986, as amended from time to time, in such manner as the Board of Directors shall determine. Any such assets not so distributed shall be distributed by the district

court of the county in which the principal office of the Corporation is then located, exclusively for the purposes or to such organizations, as such court shall determine to be consistent with the purposes of the Corporation.

## ARTICLE 13 BYLAWS

Provisions for the regulation of the internal affairs of the Corporation shall be set forth in the Bylaws. The Board of Directors of the Corporation shall be authorized to amend the Corporation's Bylaws at a properly noticed special or regular meeting of the Board of Directors. Neither these Articles nor the Bylaws of the corporation shall be amended or otherwise changed or interpreted to be inconsistent with the Bella Commons Phase 2 Homeowners Association Declaration.

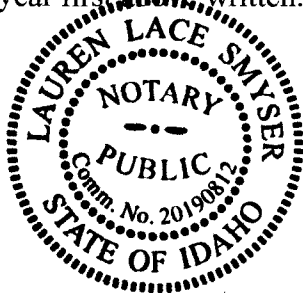
