



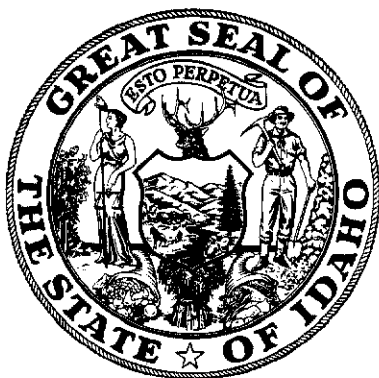
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

OF

CAMAS WHEAT BREEDING, INC.

KNOW ALL BY THESE PRESENTS:

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

I.

The name of the corporation is CAMAS WHEAT BREEDING, INC.

II.

The period of its duration is fifty (50) years.

III.

The purpose or purposes for which the corporation is organized are:

(A) To promote the general welfare of agriculture through the genetic improvement of agricultural crops; to provide a mechanism for the increase and distribution of these improved plant types; to maintain a permanent seed and plant collection for the preservation of plant breeding stocks and their further distribution to national seed storage centers; to produce, maintain and distribute genetically segregating plant populations, useful in plant breeding and plant genetic studies; to provide a center for the general promotion of plant breeding studies and plant genetic studies.

(B) To generally engage in, do and perform, any enterprise, act, or vocation that a natural person might or could do or perform; so long as in conformance with the other purposes herein enumerated.

(C) To engage in the business of buying, acquiring, giving, owning, leasing, transferring, encumbering, and generally dealing in real and personal property so long as in conformance with

1 (D) To borrow money for the use of said corporation and
2 to issue securities therefor and to pledge, mortgage, hypothecate
3 and otherwise dispose of the real, personal and intangible
4 property of the corporation as security therefor.

5 To do all things in connection with its objectives per-
6 mitted by law and to exercise any and all powers not prohibited
7 by law as pertains to organizations of this type.

8 IV.

9 The address of the initial registered office of the
10 corporation is 1204 East "F" Street, Moscow, Idaho 83843,
11 and the name of its initial registered agent at such address
12 is Warren K. Pope.

13 V.

14 The aggregate number of shares which the corporation shall
15 have authority to issue is FIVE HUNDRED THOUSAND DOLLARS
16 (\$500,000.00), which shall be Five Thousand (5,000) shares of
17 capital stock, the par value of each share shall be One Hundred
18 Dollars (\$100.00), and such stock shall be nonassessable.

19 VI.

20 The affairs of this corporation shall be conducted by a
21 Board of Directors of at least three in number, with the exact
22 number, manner of selection and qualifications as determined by
23 the By-Laws. The Board of Directors may appoint an Executive
24 Committee which shall possess and may exercise the powers of
25 the Board of Directors in the management and direction of the
26 affairs of the corporation during the intervals between meetings
27 of the Board of Directors.
