**Attachment to
Articles of Amendment for
The Morgan Family Foundation, Inc.**

1. **Article III shall be amended to read and provide in its entirety as follows:**

The members shall be TOM MORGAN, the descendants of TOM MORGAN who are over age eighteen (18), and such other persons as may be designated or admitted as members in accordance with the provisions provided for in the Bylaws of the Corporation. In the event there are no members, or there are members who are not active in exercising their rights as a member of the Corporation, the Idaho Community Foundation may exercise the rights of a member to approve action requiring the vote or consent of members.

The Incorporator shall constitute the initial member of the corporation.

2. **Article IV shall be amended to read and provide in its entirety as follows:**

The Corporation shall be managed by a Board of not more than six (6) directors nor less than three (3) directors who may also be referred to as "Trustees." The directors shall have a term of three (3) years.

The term of all directors shall begin immediately after their election.

The Incorporator shall constitute the initial Board of Directors.
