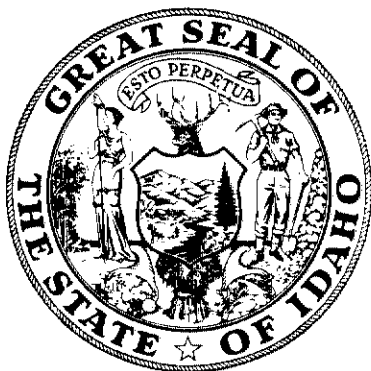

ARTICLES OF INCORPORATION

of

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, HUMMEL/DROPPING ARCHITECTS, P.A., has adopted the following Articles of Amendment to its Articles of Incorporation.:

I

The name of the corporation is HUMMEL/DROPPING ARCHITECTS, P.A.

II

The following amendment to the Articles of Incorporation was adopted by the shareholders of the corporation on December 5, 1985, in the manner prescribed by the Idaho Business Corporation Act:

Article I of the Articles of Incorporation of Hummel/Dropping Architects, P.A., shall be amended to read as follows:

The name of this corporation shall be HUMMEL, LAMARCHE & HUNSUCKER ARCHITECTS, P.A.

III

The number of shares of the corporation outstanding at the time of such adoption was 76, and the number of shares entitled to vote thereon was 76.

IV

The number of shares voted for such amendment was 76, and the number of shares voted against such amendment was 0.

Such amendment does not effect a change in the amount of stated capital.


