

ARTICLES OF INCORPORATION
of the

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a Corporation, under the laws of the State of Idaho.

— And we hereby certify: —

First. That the name of said Corporation is SILVER CITY ELECTRIC LIGHT COMPANY.

Second. That the purpose for which it is formed is to conduct and carry on a general electric light business in the town of Silver City, County of Owyhee, State of Idaho.

Third. That the place where its principal business is to be transacted shall be the town of Silver City, County of Owyhee, State of Idaho.

Fourth. That the term for which it is to exist is Twenty-five years from and after the date of its incorporation.

Fifth. That the number of its directors shall be five and that the names and residences of those who are appointed for the first year are:
