ARTICLES OF INCORPORATION
of
IDAHO SPECIAL OLYMPICS

KNOW ALL MEN BY THESE PRESENTS:

THAT we, the undersigned, being of legal age and being citizens of the United States of America and residents of the State of Idaho, do hereby, as incorporators hereof, form a non-profit cooperative association under the laws of the State of Idaho, according to and in compliance with Chapter 10, Title 30, Idaho Code, and we do hereby adopt Articles of Incorporation, as follows:

ARTICLE I

NAME

The name of this corporation shall be IDAHO SPECIAL OLYMPICS, INC.

ARTICLE II

PURPOSES

The purposes for which this corporation is formed are as follows:

1. To stimulate interest in competitive athletics, physical fitness and recreation for all mentally retarded children and adults in the state of Idaho.
2. To coordinate all such or related activities with any similiar organizations within or without the State of Idaho.
3. To receive monies, equipment or labor from any source, private, city, county, state, federal, or whatever, or purchase, convey, mortgage, and lease all kinds of real and personal property or otherwise use funds for the accomplishment of the purposes stated herein.
4. To borrow money and to draw, make, accept, endorse, assign, guarantee, execute and issue notes, checks, drafts, bonds, debentures, negotiable instruments and other instruments for the payment of money and to mortgage or pledge its property to secure such obligations.
5. To have, exercise and enjoy all powers now or hereafter granted to corporations organized under the laws of the State of Idaho and particularly all the powers and privileges granted to corporations under Chapter 10, Title 30, Idaho Code, and in present and future amendments thereto, and to engage in any other activity and to do any act or other thing necessary to carry into effect the aforementioned purposes.
6. To exercise and perform all of the above described powers both within and without the State of Idaho.

ARTICLE III

PRINCIPAL PLACE OF BUSINESS

The location and post office address of the registered office of said corporation shall be: Box 816, Annex #6, Statehouse, Boise, Idaho.

ARTICLE IV

DURATION

The duration of this corporation shall be perpetual.

ARTICLE V

Dissolution

In the event this corporation shall be dissolved, all assets thereof shall be distributed to such organization or organizations organized and operated exclusively for charitable, educational or scientific purposes as shall at said time qualify as an exempt organization under Section 501(c) (3) of the Internal Revenue Code of 1954 as the Board shall determine. This corporation is not formed for profit. All property and funds of this corporation, legal or equitable, shall be and continue as trust properties or funds to be used soely for carrying out the objects and purposes of this corporation.

ARTICLE V I

MEMBERS

This corporation is organized without capital stock and the rights and interest of all the members shall be equal. The qualification for members shall be provided in the By-Laws.
