ARTICLES OF INCORPORATION

SCENIC VALLEY SUB NO. 3 PROPERTY OWNERS, INC.

We, the undersigned residents of the State of Idaho, being 18 years or more of age, do hereby associate ourselves together for the purpose of forming a nonprofit corporation under the statutes of the State of Idaho.

### ARTICLE ONE

### NAME AND LOCATION

The name of the corporation shall be Scenic Valley Sub No. 3 Property Owners, Inc., and its location shall be Star Route, Lowman, County of Boise, State of Idaho.

## ARTICLE TWO

#### DURATION

The period of duration of this nonprofit corporation shall be perpetual.

#### ARTICLE THREE

#### PURPOSE CLAUSE

The purposes of this corporation are:

- (a) To develop a community designed for safe, healthful, and harmonious living.
- (b) To promote the collective and individual property and civic interests and rights of all persons, firms and corporations owning property in Scenic Properties Subdivision No. 3, as this property is shown on the official plat thereof, filed as instrument number 76049, records of Boise County, Idaho, (hereafter the subdivision).
- (c) To own, lease, care for, maintain, improve and manage all common or joint use areas set aside for park, picnic, recreation and scenic tracts for the sole use and enjoyment of all owners of lots in the subdivision, to own, lease, care for, maintain, improve, and manage all parcels of land designated as "Reserve Tracts" in the subdivision to be used as parks, bridle trails, playgrounds, reservoir sites, well sites, and for other uses and purposes to develop and protect the subdivision for the common good of all owners of lots in the subdivision; to levy annualy dues upon each owner of a lot in the subdivision to finance all of the foregoing.
- (d) To engage in the transaction of any or all lawful business for which a nonprofit corporation may be incorporated under the Idaho Nonprofit Corporation Act.

### ARTICLE FOUR

## NONSTOCK CORPORATION

The corporation is to be organized upon a nonstock, certificate of membership basis and no dividends or pecuniary profits shall be delcared or paid to the members hereof. These memberships shall be nonredeemable, nontransferable, and non-dividend bearing.

### ARTICLE FIVE

### DIRECTORS

The number of directors constituting the initial board of directors of the forporation is five, and the names and addresses of the persons who are to serve as initial directors are as follows:

# ELECTION OF DIRECTORS

## ARTICLE SEVEN

## CORPORATE OFFICERS AND THEIR FUNCTIONS

The general officers of the corporation shall be president, vice-president, and secretary-treasurer.

The board of directors may provide for the appointment of additional officers as they may deem for the best interest of the corporation.

Whenever the board of directors may so order, any two offices, the duties of which do not conflict, may be held by one person.

The officers shall perform any additional or different duties as shall from time to time be imposed or required by the board of directors, or as may be prescribed from time to time by the bylaws.

### ARTICLE EIGHT

### MANAGEMENT BY MEMBERS

This corporation has members and the management of its affairs is to be vested in its members pursuant to Section 30-314(c), Idaho Code.

### ARTICLE NINE

### ELECTION OF OFFICERS

The officers shall be elected by the directors, who shall first be elected by the members of the corporation.

### ARTICLE TEN

## MEMBERSHIP REQUIREMENTS

Any owner of a lot in the subdivision is a member but may be discharged or expelled as provided in the bylaws.

### ARTICLE ELEVEN

### **AMENDMENTS**

These articles may be amended in the manner provided by statute at the time of amendment.
