ARTICLES OF INCORPORATION

OF

CRAIG ALAN SINKINSON, M.D., P.A.

(A Professional Corporation)

I, the undersigned, a natural person over the age of 18 years do hereby form a professional corporation under the laws of the State of Idaho, as contained in Chapter 13 of Title 30, Idaho Code, entitled "Professional Service Corporation Act," and to that end do hereby certify:

ARTICLE I
NAME

The name of the corporation shall be Craig Alan Sinkinson, M.D., P.A.

ARTICLE II
PURPOSES AND POWERS

The purposes for which the corporation is organized are:

A. To engage in the professional practice of medicine as a professional corporation as the same is now or hereafter defined by statute, rule and regulation;

B. To invest funds in real property, personal property, mortgages, stocks, bonds or any other types of investments and to own or lease real or personal property necessary for the rendering of such professional services; and

C. To engage in such other businesses or professions as may be authorized or permitted by the Professional Service Corporation Act (Chapter 13 of Title 30 of the Idaho Code) and to the extent not inconsistent with the foregoing as may be permitted by the Idaho Business Corporation Act (Chapter 1 of Title 30 of the Idaho Code).

ARTICLE III
DURATION

The period of duration of the corporation shall be perpetual.

ARTICLE IV
REGISTERED OFFICE

The registered office of the corporation in the State of Idaho, County of Gooding, shall be located at 645 River Road, Hagerman, Idaho 83332. The post office address of the registered office of the corporation in the State of Idaho, County of Gooding, shall be P.O. Box 659, Hagerman, Idaho 83332. Craig A. Sinkinson shall be the registered agent at the registered office.

ARTICLE V
CORPORATE STOCK

The aggregate number of shares which the corporation shall have authority to issue is 10,000, all of which shall have a no par value.

ARTICLE VI

ARTICLE VII
MANAGEMENT

The business of the corporation shall be managed by a board of at least 3 directors, except that if all of the shares of the corporation are owned beneficially and of record by either 1 or 2 stockholders, the number of directors may be less than 3 but not less than the number of stockholders. Directors need not be shareholders. A director shall hold office for the term for which he was named or elected and until his successor is elected and qualified.

There shall be 1 director on the initial board and he shall be Craig Alan Sinkinson, who shall serve as a director until his successor is elected and qualified.

ARTICLE VIII
BY-LAWS

The power to adopt, repeal and amend the by-laws of the corporation shall be in the stockholder. The by-laws may be amended, adopted or repealed by the stockholder.
