To the Secretary of the State of Idaho:

We, the undersigned, desiring to form a non-profit corporation under the statutes of the State of Idaho, do hereby make, subscribe, and acknowledge as follows:

Article 1 Name

The name of the corporation shall be: Church of the Living God, Inc

Article 2 Purpose

The purpose for which the corporation is organized is Nonprofit Religious Corporation. The corporation is a Religious Corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Religious Corporation Law primarily for religious purposes.

The specific purposes for which this corporation is organized are exclusively religious, charitable, literary or educational within the meaning of the Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Code including, but not limited to, for such purpose, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code; the establishing and maintaining of religious worship; the building, maintaining and operating of churches, bookstores, parsonages, schools, colleges, chapels, radio stations, television stations, rescue missions, missionary auxiliaries, missions outreaches, print shops, day care centers, camps; and any other ministries that the Board of Directors may be led of God, all of which are established for the benefit of the congregation of the corporation by providing opportunities for spiritual, physical, intellectual, social, and cultural development. Without limiting the generality of the foregoing, the corporation is organized to act as a church for the sole purpose of proclaiming the Gospel of Jesus Christ throughout the world.

Article 8 Dissolution

In the event of dissolution of the corporation, no part of the corporation's earnings or assets shall inure to the benefit of any of its members. The residual assets of the corporations shall be distributed to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c) of the Internal Revenue Code of 1986, or corresponding sections of any prior or future law, or to the federal, state, or local government for exclusive public purpose.

Article 9 Additional Provisions


This corporation shall have the power to purchase, lease or otherwise acquire property, support missionaries and missions, raise funds, and do those things necessary to proclaim the Gospel in an adequate manner.


The corporation is empowered to hold any property, or any undivided interest therein, without limitation as to amount or value; to dispose of any such property and to invest, reinvest, or deal with the principal or the income in such manner as, in the judgment of the Board of Directors, will best promote the purposes of the corporation without limitation, except such limitations, if any, as may be contained in the instrument under which such property is received, these Articles of Incorporation, the By-Laws of the corporation, or any applicable laws; to do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof, but not for the pecuniary profit or financial gain of its directors or officers except as permitted under the Not-for-Profit Corporation Law.


No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the aforementioned purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.


