#### ARTICLE I

#### Duration of the Corporation

The period of duration of this Corporation is perpetual.

#### ARTICLE III

## Purpose

The general purposes and objectives for which the Corporation is organized are: (a) To engage in any lawful business whatsoever, and (b) to have and to exercise all the powers now or hereafter conferred by the laws of the State of Utah upon corporations organized pursuant to the laws of the State of Utah and any and all acts amendatory thereof and supplementary thereto and to engage in any other lawful activities.
