ARTICLES OF INCORPORATION

OF

BUEHLERS, INC.

We, the undersigned, being three or more natural persons of full age, at least two-thirds of whom are citizens of the United States or of its territories or possessions, have this day voluntarily associated ourselves for the purpose of forming a private corporation under the laws of the State of Idaho, and to that end hereby adopt articles of incorporation as follows:

ARTICLE I

NAME

The name of the corporation is BUEHLERS, INC.

ARTICLE II

PURPOSES

The principal purpose for which the corporation is organized is to engage in the business of farming and ranching.

The corporation shall further be authorized to acquire, manage, mortgage, pledge or otherwise deal in real or personal property, to participate in general or limited partnerships to establish and francise other similar businesses, and to carry on such other business as may be necessary, convenient, or desirable and to engage in all other activities and businesses not prohibited by law.
