Addendum: ARTICLES OF INCORPORATION application for Post Falls Thrift, Inc.

Article 2

- to provide vocational opportunities (evaluation, training, employment) for persons with disabilities, with social and economic disadvantages, and/or who are elderly
- to fund programs by accepting and selling community donations

To this end, the corporation shall at all times be operated exclusively as specified in Section 501(c)(3) of the IRS Code.
