DECREE AND JUDGMENT
OF DISSOLUTION

THIS MATTER, having been regularly heard by this Court on the 17th day of September, 1968, at 2:00 o'clock P.M. on the Petition of Royal Baking Co., Inc., an Idaho corporation, made in its name by its Directors for a Decree and Judgment declaring said corporation dissolved and Notice of the Application for Voluntary Dissolution having been given in accordance with that certain Order for Hearing Application for Voluntary Dissolution and in accordance with the statutes made and provided in such cases, and Freddie A. Parker, one of the Directors of said Royal Baking Co., Inc., and his counsel, Elbert E. Gass of the law firm of Clemons, Skiles & Green, having appeared in person and evidence, both oral and documentary, having been introduced, and good cause appearing therefor,

IT IS HEREBY ORDERED That Royal Baking Co., Inc., an Idaho corporation, be, and the same hereby is, declared to be duly wound up, subject to the paying of incurred current monthly operating expenses, its assets distributed as herein provided after the incurred current monthly operating expenses have been paid, and its Directors discharged from their duties and liabilities to creditors and shareholders; and

IT IS FURTHER ORDERED That the assets of the said corporation be, and they hereby are, distributed as follows:

1. To Freddie A. Parker 74.04% of all property, real and personal, of said Royal Baking Co., Inc.; and
2. To Freddie A. Parker, the duly-appointed, qualified and acting guardian of the person and estate of Gregory F. Parker, a minor, 25.96% of the property, real and personal, of the said Royal Baking Co., Inc.,
and

IT IS FURTHER ORDERED That said Royal Baking Company, Inc., be, and it hereby is, declared to be dissolved and a certified copy of this Decree and Judgment declaring the said corporation dissolved shall be filed in the office of the Secretary of State of the State of Idaho and in the office of the County Recorder of Bear Lake County.
