ARTICLES OF INCORPORATION SECTION OF STATE SOUTHEAST IDAHO GYNNASTICS SCHOOL 29 N & P 9 27

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

I. NAME

The name of the corporation is Southeast Idaho Gymnastics School, Inc.

II. DURATION

The corporation shall come into existence January 1, 1988, and the period of its duration is perpetual.

III. PURPOSES

The purpose or purposes for which this corporation is organized are to operate a gymnastic and dance business and related services and for the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
