ARTICLES OF INCORPORATION

o f

COMMERCIAL AIR, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, each of whom is a bona fide resident of the State of Idaho, of legal age and a citizen of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho and pursuant thereto certify as follows:

ARTICLE I

The name of this corporation shall be COMMERCIAL AIR, INC.

ARTICLE II

This corporation shall have perpetual existence.

ARTICLE III

The objects and purposes for which this corporation is formed are: as principal, agent or otherwise, to do in any part of the world any and all things hereinafter set forth to the same extent as natural persons might or could do. In furtherance thereof, but not in limitation of the general powers conferred by the laws of the State of Idaho we expressly provide that this corporation shall have power:

(a) To purchase, take, hold, own, acquire by operation of law or otherwise, lease, mortgage or otherwise hypothecate any and all kinds of real and personal property or any interest therein or appurtenant thereto, and to sell or exchange any such real or personal property or any interest therein, or to engage in any and all undertakings or business necessary,

proper or convenient to the improvement or betterment of any real or personal property owned or acquired by this corporation.

- (b) To engage in or carry on as manufacturer, wholesaler, or retailer the manufacture, sale or exchange of any and all kinds of goods, wares, or personal property.
- (c) To engage in or carry on either a general whole-sale or retail business of any and all kinds.
- (d) To operate, for hire or otherwise, as a private or contract carrier, or for the purpose of carrying on the commercial aerial fertilizer or dusting business, any and all types of airplanes, aircraft or other machines, within or beyond the territorial limts of the United States and to acquire, maintain and operate any and all necessary airfields or locations; to give instruction and training in the art of navigation and aviation and to own and operate machine shops, laboratories and any and all other necessary adjuncts thereto; to own, build, trade, sell, lease or otherwise deal in or operate airplanes and aircraft of any and all kinds; and to engage in the business of crop dusting, planting of crops, and weed control and eradication by the use of airplanes and related equipment and all business connected with or incidental thereto.
- (e) To carry on and conduct a general contracting business; to take or receive any contracts or assignments of contracts for construction or relating thereto and to use and operate all kinds of equipment, mechanical or otherwise, in the performance of same.
- (f) To enter into, make, perform and carry out contracts of every kind, amount and character with any person, firm,

association, partnership or corporation.

(3) To purchase, own, sell, convey, mortgage, pledge, exchange, acquire by operation of law or otherwise, personal property of whatever kind or character, including, but not

restricted to, debts, dues, demands, choses in action, evi-

dence of debt, bonds, or stocks of other corporations or

otherwise, both public and private.

(h) To contract with the United States of America, any foreign country, or with any state, city, county, or other governmental subdivision.

- (i) To borrow and lend money from and to any person, firm, partnership, association or corporation and to make, take or execute notes, mortgages, bonds, deeds of trust or other evidences of indebtedness to secure payment thereof.
- (j) To purchase, exchange, or otherwise acquire and own the corporate common or preferred stocks, bonds, or other securities of any other corporation, public or private, and also to purchase, redeem, or otherwise acquire its own capital stock insofar as not contrary to the constitution or laws of the State of Idaho, and to sell its own corporate common or preferred stock, bonds, dehentures or other securities or evidences of indebtedness.
- (k) To purchase or otherwise acquire letters patent, licenses, inventions, rights or privileges either in the United States or in any other part of the world, and to manufacture or produce, trade and deal in all machinery, articles, appliances or otherwise, capable of being manufactured, produced or traded in, by virtue of, or in connection with any letters patent, licenses, inventions, rights and privileges.
 - (1) To merge or consolidate with any corporation in

such ranger as may be permitted by law.

- (m) In addition to the foregoing powers also to have all authority, power or right granted to comporations by the constitution and laws of the State of Idaho and any amendment thereto.
- (a) To do and perform every act or thing necessary to carry out the above enumerated purposes, calculated directly or indirectly to the advancement of the interest of said corporation and to the enhancement of the value of its stock or property of any kind or character.

VSEICTE IA

The registered office of this corporation and the principal place for the transaction of its rusiness is Caldwell, Canyon County, Idaho, but such registered or principal office may be changed from time to time by action of the Board of Directors of this corporation.

ARTICLE V

The number of directors of this corporation shall be three (3). It is not accessary that a director be a share-holdwoof this corporation.

ARTICLE VI

The amount of the dely authorized capital stock of this corporation is TWENTY FIVE THOUSAND DOMINARS (\$25,000.00), divided into twenty five thousand (25,000) shares of common capital stock of the par value of \$1.00 per share.

Each common share shall be entitled to one (1) vote, and such common shares shall have dividend participating rights, and all of said stock shall be non-assessable.

From time to time, the capitalization of this corporation may be increased or decreased as provided by low and if the

capitalization is increased such amendment may provide for different classes of stock with voting or dividend rights or privileges as may be provided in such amendment.

TRICIE VII

These articles may be amended as provided by the laws of the State of Idaho and may be amended by action of the Board of Directors as provided in the following Article VIII.

ARTICLE VIII

In furtherance and not in limitation of the powers conferred by statutes, the Board of Directors of this corporation is expressly authorized:

- (a) To remove at any time any officer elected or appointed, by vote of a majority of the Board.
- (b) To repeal and amend the By-Laws of the corporation and to adopt new By-Laws.
- (c) To authorize and cause to be executed mortgages, liens or other encumbrances upon the real and personal property of the corporation.
- (d) To set apart out of any of the funds of the corporation available for dividends a reserve or reserves for depreciation and losses of every character, or to use any of such reserves in the manner allowed by the laws of the State of Idaho.
- (e) When and as authorized by the affirmative vote of the holders of a majority of the stock issued and outstanding, having voting power given at a shareholders meeting duly called for that purpose, the Board of Directors shall have power and authority to lease, sell or exchange all or any part of the assets of the corporation upon such terms and conditions and

for such consideration, which may be in whole or in part shares of stock in any other corporation or corporations, as its Board of Directors may deem expedient and for the best interests of the corporation.

(f) To determine the amount and time of payment of any dividends out of any funds which may be lawfully used for such purpose.

ARTICLE IX

The private property of the shareholders of this corporation shall not be subject to the payment of corporate debts of this corporation.

ARTICLE X
