ARTICLES OF INCORPORATION
OF
EXCEL HOME CENTERS, INC.

The undersigned, acting as incorporator of the corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I.

The name of the corporation is:

EXCEL HOME CENTERS, INC.

ARTICLE II.

The period of its duration is perpetual.

ARTICLE III.

The purpose or purposes for which the corporation is organized is to transact any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
