ARTICLE TWO

NON-PROFIT PURPOSE

A) This corporation is organized exclusively for operating a fraternal lodge for social, benevolent, and charitable purposes within the meaning of Section 501 (c) (8) of the Internal Revenue Code. Notwithstanding any other provisions of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501 (c) (8) of the Internal Revenue Code. No part of the corporate assets, income or profit shall be distributable to, or inure to the benefit of its officers, trustees or members except to the extent permitted for a non-profit corporation under the non-profit corporation laws of the State of Idaho and under Section 501 (c) (8) of the Internal Revenue Code. The Corporation shall not take steps which serve to facilitate the transaction of specific business by its officers, trustees or members; or promote the private interest of any officer, trustee or member; or engage in

any activity which would constitute a regular business of a kind ordinarily carried on for profit.

B) The grand body of the International Order of the Odd Fellows, State of Idaho organization, shall maintain a reversionary interest in this corporation such that if this corporation is dissolved any assets of this corporation shall revert to the State organization. Further, this corporation shall be subject to the laws, rules, and regulations of the State of Idaho Grand Body (State Organization).

### ARTICLE THREE

#### DURATION

The period of the duration of this corporation is perpetual.

### ARTICLE FOUR

#### MEMBERS

This corporation is a membership corporation, has no capital stock and is not organized for pecuniary profit.
