CONSENT TO AMENDMENT OF ARTICLES OF INCORPORATION OF

GARRETT TRANSFER & STORAGE COMPANY.

C. A. Garrett, O. W. Garrett, Wains Garrett and Carl Sahlberg, being all of the share holders entitled to vote on the question of an amendment to articles of incorporation of said Company and being all of the share holders of said corporation and desiring to amend the articles of incorporation of said corporation and for that purpose desiring to take advantage of and to comply with the provision of Sub Section 5 of Section 33, Chapter 262 of the Session Laws of Idaho for 1929, hereby adopt the following amendment to the articles of incorporation of Garrett Transfer & Storage Company, to-wit:

Article VI of said articles of incorporation is amended to read as follows:

## VI

"The amount of capitol stock of said corporation shall be one hundred thousand dollars (\$100,000.00) and shall be divided in to one thousand (1000) shares. The par value of each share shall be one hundred dollars (\$100.00)."

"The total number of shares, including those previously authorized, which the corporation will henceforth be authorized to have is one thousand (1,000)."

"The number of shares that have a par value is one thousand (1,000) and the par value thereof is one hundred dollars (\$100.00) per share or one hundred thousand dollars (\$100,000.00) for all."

"The number of shares that have no par value is zero (0)."

"The shares are not divided into more than one class."
