We, Samuel McKeever, W. L. McLaughlin, J. E. Clark, W. H. Wood, H. B. Larson, Frank Wheaton, R. P. Finley, and A. H. Egbert, Citizens of the United States, Residing at Coeur d'Alene, County of Kootenai, and Territory of Idaho, hereby associate together for the purpose of creating a Corporation under the laws of the Territory of Idaho, authorizing the formation of Corporations for mining and other purposes, and in compliance with the provisions of said laws we do hereby state and Certify:

First.

That the Corporate name of this Company is and shall be "The Skeptic Mining Company"

Second

That this Company is formed for the sole purpose of mining the ores and minerals contained in the Mines situated in said Kootenai County, in the vicinity of Fort Coeur d'Alene, in said Territory of Idaho, and to purchase claims and land, not to exceed the amount limited by law, for the purpose of mining said ores and minerals, and to issue full paid stock in payment therefor,

Third

That the amount of Capital Stock of this Company is and shall be One Million Dollars (\$1,000,000) divided into one hundred thousand Shares of the par value of two dollars (\$2) each

Fourth

That the existence of the Company shall continue for the term of fifty (50) years.

Fifth

That the number of Trustees who shall manage the concerns and business affairs of said Company, is, and shall be five, and Samuel McKewen, W. R. Wallace, S. E. Clark, W. L. McLaughlin and W. H. Hood, are the names of the persons who shall be the trustees of said Company for the first year, or until January 1st 1885, and all of whom are Citizens of the United States and residents of Kootenai County in the Territory of Idaho,

Sixth

That the principal office and place of business of said Company shall and is to be located at Fort Coeur d'Alene, Kootenai County, Territory of Idaho, and the mining operations are also to be carried on in the vicinity of said Fort Coeur d'Alene
