# CERTIFICATE OF INCREASE OF THE CAPITAL STOCK OF THE

## HYPOTHEEK MINING AND MILLING COMPANY.

We, the undersigned chairman and secretary of the stockholders meeting called for the purpose of increasing the capital stock of the Hypotheek Mining and Milling Company, and a majority of the directors of said corporation, do hereby certify:

I.

That at a special meeting of the Board of Directors of the Hypotheek Mining and Milling Company, a corporation duly organized and existing under and by virtue of the laws of the State of Idaho, held at Wallace, Idaho, on the 6th day of fanuary 1914, by a majority vote of the directors of said corporation. to-wit: W. W. Dandson, J. H. Skenn and Ottofolismen.

being a majority of the five directors of said corporation, a special meeting of the stockholders of said corporation was duly called to be convened on the ninth day of March 1914, at 10 o'clock A. M. of said day, at the office of said Hypotheek Mining and Milling Company in the Eagle Block, at Wallace, Idaho, for the purpose of considering the proposition of increasing the capital stock of said corporation from One Million Five Hundred Thousand (1,500,000) shares of the par value of ten cents (10¢) per share, or One Hundred Fifty Thousand Dollars (\$150,000), to Two Million (2,000,000) shares of the par value of ten cents (10¢) per share, or Two Hundred Thousand Dollars (\$200,000).

II.

That notice of the time and place of said meeting and the

object thereof as aforesaid, was published in the Wallace Miner, a weekly newspaper published in the City of Wallace, County of Shoshene, State of Idahe, in which said county the principal place of business of said corporation is located, for a period of at least thirty (30) days, the first publication thereof being the issue of said newspaper dated the Jan day of February 1914, and once a week thereafter for each consecutive week therefor, for the full period of thirty (30) days and until the day of March 1914, the date of the last publication thereof; and that in addition to such publication a copy of such notice was served upon each of the stockholders of said company as shown by its books by mailing a full, true and correct copy of such notice to each of said stockholders at their respective addresses as shown by the stock books of such corporation at least thirty (30) days before the date of said proposed meeting, to-wit, March 9, 1914.

#### III.

That said notice contained the amount to which it was proposed to increase said capital stock of said corporation, to-wit: the amount of Two Hundred Thousand Bollars (\$200,000), divided into Two Million (2,000,000) shares of the par value of ten cents (10¢) per share.

### IV.

That pursuant to said notice a meeting of the stockholders of said corporation was held on the 9th day of March 1914 at 10 o'clock A. M. of said day, at the office of the company in the Eagle Block at Wallace, Idaho aforesaid, at which meeting there were present and duly represented more than two-thirds (2/3) of

the entire capital stock of said corporation, to-wit: 1.077.545 shares.

W. W. Davidson was then and there elected chairman of said stockholders meeting and Otto A. Olsson was elected Secretary thereof, and thereupon by a vote of 1.077.545 shares of stock, the same being more than two-thirds (2/3) of the entire capital stock of the corporation the following resolution was adopted, to-wit:

"WHEREAS, the development of the mining properties owned and operated by this company has reached a stage where it is important and necessary and for the best interests of the comimportant and necessary and for the best interests of the company to erect and operate a concentrator of about Three Hundred (300) tons daily capacity upon a site near a railroad, and also a tramway for the transportation of cres from the company's mine to said concentrator, and to insure a speedy and substantial completion of the same after the ore has been thoroughly explored to a lower level, and

WHEREAS, the company has no funds available for the construction of these improvements, and at the present time no means of raising funds for that purpose, and

whereas, the raising of funds sufficient for such purposes by the levying of assessments upon the outstanding capital stock of the corporation is impracticable if not impossible;

Now, Therefore, Be it Resolved that the capital stock of this corporation be and the same is increased from One Hundred Fifty Thousand Dollars (\$150,000) divided into One Million Five Hundred Thousand (1,500,000) shares of the par value of ten (10) cents per share, to Two Hundred Thousand Dollars (\$200,000) divided into Two Million (2,000,000) shares of the par value of ten (10) cents per share, pursuant to the provisions of the Constitution and laws of the State of Idaho concerning corporations and particularly to the provisions of said Constitution and statutes particularly to the provisions of said Constitution and statutes covering the increase of the capital stock of corporations."
