ARTICLES OF INCORPORATION OF THE FIRST METHODIST EPISCOPAL

KNOW ALL MEN: That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of incorporating under the laws of the State of Idaho, and in pursuance of the purposes for which we have been elected, as hereinafter set forth, a religious corporation to be known as:

ARTICLE 1.

The name of the corporation is, The First Methodist Episcopal Church of Montour, Idaho.

ARTIGLE 11.

The purpose for which the corporation is formed is, To establish a church building, and parsonage in the village of Montour, and County of Gem, State of Idaho; and in connection therewith suitable and customary organization, for the purpose of public worship and religious training, according to the rules and "Discipline" of the Methodist Episcopal Church of the United States of America.

ARTICLE 111.

That the principal place of business of this corporation shall be in the village of Montour, County of Gem, State of Idaho.

ARTICLE 1V.

That the term of the incorpozation shall be fifty years from the date hereinafter written.

ARTICLE V.

The amount of the authorized capital stock: None.

ARTICLE V1.

That the number of trustees who shall have the mamagement of the affairs as aforesaid shall be 3, and the names of the trustees elected for the first year are: A. D. Stanton, R. E. Noland, and H. A. pugh.
