**ARTICLES OF INCORPORATION**

**OF**

**GREATER POCATELLO CHAMBER OF COMMERCE FOUNDATION, INC.**

The undersigned, acting as incorporators of a corporation under the Idaho Non-Profit Corporation Act, adopt the following Articles of Incorporation for such corporation;

1. **NAME:** The name of the corporation is **GREATER POCATELLO CHAMBER OF COMMERCE FOUNDATION, INC.**
2. **NON-PROFIT:** This is a non-profit corporation.
3. **DURATION:** The period of its duration is perpetual.
4. **PURPOSES:** The purpose or purposes for which the corporation is organized are exclusively charitable, scientific or educational, and benevolent, and in order to achieve these objectives it may support specific projects and programs to improve economic and understanding and conditions in the area served by the Greater Pocatello Chamber of Commerce. The Foundation shall, in connection with its activities, support and promote education, training and research programs. To accomplish such purposes, it proposes to make distributions to organizations that qualify as exempt organizations under §501(c)(3) of the Internal Revenue Code and its regulations as they now exist or as they may hereafter be amended.
5. **MEMBERSHIP:** This corporation is to have no members or shareholders.

6. **REGISTERED AGENT AND OFFICE:** The initial registered agent is David W. Collins, and the initial registered office is located at 427 North Main Street, Suite A, Pocatello, Idaho 83204.

7. **BOARD OF DIRECTORS:** The affairs of the corporation shall be managed by its Board of Directors. The Board of Directors shall consist of seven (7) individuals. Other than the Directors constituting the initial Board of Directors, who are designated in these Articles, the directors shall be appointed by the Board of Directors of the Greater Pocatello Chamber of Commerce, Inc., located at 427 North Main Street, Suite A, Pocatello, Idaho 83204, in accordance with Subsection (b) or Subsection (e) of Section 30-314 of the Idaho Non-Profit Corporation Act. The President of the Greater Pocatello Chamber of Commerce shall always be a director of the Board of Directors of the corporation.
