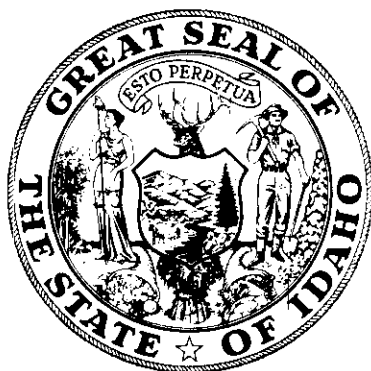

ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
TILLOTSON POWER SWEEPING, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho General Business Corporation Act, the undersigned corporation hereby adopts the following Articles of Amendment to its existing Articles of Incorporation:

First: The name of the corporation is Tillotson Power Sweeping, Inc., whose Certificate of Incorporation was issued by the Idaho Secretary of State on 7 January 1981.

Second: The following amendment of the Articles of Incorporation was adopted by a unanimous resolution of all of the shareholders of this corporation on or about the 16th day of May, 1984, in the manner prescribed by Section 30-1-59, as amended, of the Idaho Code (and in further compliance with Section 30-1-145 of the Idaho Code) all being a part of Title 30 of the Idaho Code with respect to General Business Corporations:

NAME OF CORPORATION AMENDED AND CHANGED FROM Tillotson Power Sweeping, Inc., TO TILLOTSON CONTRACTORS, INC.

Third: The number of shares of the corporation outstanding at the time of such adoption was 50; and the number of shares entitled to vote thereon was 50.

Fourth: This corporation has only one class of stock, the same being common stock; and at the time of the adoption of this amendment, only 50 shares of common or capital stock have been issued.

Fifth: As alleged herein, there was a unanimity in the affirmative vote for this amendment.

Sixth: This amendment does not relate to nor provide for any exchange, reclassification or cancellation of issued shares of stock.

Seventh: Such amendment does not effect any change in the amount of stated capital of this corporation.




