ARTICLES OF INCORPORATION

OF

CITIZENS AGAINST NUCLEAR WEAPONS AND EXTERMINATION, INC.

The undersigned, acting as incorporator under the Idaho Non-profit Corporation Act, hereby adopts these articles of incorporation.

ARTICLE I. NAME

The name of the corporation shall be Citizens Against Nuclear Weapons and Extermination, Inc. (hereinafter referred to as the Corporation).

ARTICLE II. PURPOSE

The Corporation is organized exclusively for charitable and educational purposes, including in such purposes the receipt of contributions and the making of distributions to organizations that qualify as exempt organizations under S 501(c)(3) of the Internal Revenue Code. That the Corporation will provide information and assistance to individuals or groups regarding the dangers of nuclear armaments and the resulting contamination associated with their production.

ARTICLE III. MEMBERS

Any person who subscribes to the purpose and policy of the Corporation may be a member.

ARTICLE IV. LIMITATION OF ACTIONS

No part of the funds of the Corporation shall inure to the benefit of, nor be distributable to, its officers or directors, or other private persons except that the Corporation shall be authorized

and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in Article II hereof. No substantial part of the activities shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in any political campaign of any candidate for public office.

Notwithstanding any other provisions of the articles, the Corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Tax under S 501(c)(3) of the Internal Revenue Code.

ARTICLE V. DURATION

The duration of the Corporation shall be perpetual. Upon the winding up and dissolution of the Corporation, the Board of Directors shall, after paying or making provisions for paying all of the debts and obligations of the Corporation, distribute the remaining assets of the Corporation to a non-profit fund, foundation, or corporation which has established its tax exempt status under S 501(c)(3) of the Internal Revenue Code.

ARTICLE VI. REGISTERED OFFICE AND AGENT

The location and address of the initial registered office of the Corporation shall be: W. 2535 Riverview Dr., Coeur d'Alene, Idaho 83814.
